Austin, TX	Inquiry was made to see if a permit is required to sample from a tent set up on street for a street festival. The city attorney said that sampling would not be permissible from the tent, so the permit question was moot.
Birmingham, AL	RJR Law Dept. talked with Teague and Brown on 10/29/99 and with Vivian of City Finance on 4/18/00. Michael Wright Consulting talked with Topazy on 4/6/00.
Buffalo, NY	Permit not required to distribute samples indoors. Permit not required to distribute samples in a bar, but sampling is prohibited in a bar if the bar is open to the general public.
East St. Louis, IL	No permit required to sample in a bar provided no minors are allowed in the bar.
Hartford, CT	Sampling may be conducted on the premises of a licensed tobacco dealer. If the premises does not have a dealer's license, the party giving away the samples must be a licensed tobacco distributor. A non-tobacco company, such as a third party supplier to RJRTC, could not qualify for a distributor's license. RJRTC would have to be the licensed distributor.
Milwaukee	A sampling permit is not required if the venue where the sampling is to be done has a tobacco dealer's license. If the venue does not have a dealer's license, an application for a sampler's license must be made in the name of the venue (per advice of City Licensing Dept. on 1/31/00).
